NEFA receives funding from a number of public and private sources. Recognition encourages these supporters to continue contributing to the arts. NEFA therefore requires that appropriate credit appear in all programs, advertising, publicity, and promotional materials related to the funded project. Failure to credit NEFA *and* its supporters will result in cancellation of a grant.

As funding may change from year to year, and because it is absolutely necessary that proper credit be given to our most current supporters, we ask that an effort be made to make sure the credit language is up to date. If additional funding sources relating to your grant are added, we will notify you with updated crediting information.

If you are receiving NDP subsidy for an engagement with an Australian or Dutch company, please refer to the appropriate crediting statement below. You will find both print and web-ready formats for PC and Mac.

### **Guidelines for use of the logo**

- The logo is meant to enhance (not to replace) the credit language that is specified in your grant award letter. When possible, please use both the credit language and the NEFA logo.
- If you have a website, you may credit NEFA by placing the NEFA logo and a link to NEFA on your site.
