As NEFA's new executive director, I am pleased to share this report on our work over the past year.

Though I began my role in July of 2023, I had the opportunity to connect with staff and board in the months preceding my formal start. I observed how staff listen and gather feedback from the field and how that impacts our values-driven work. As we begin a new strategic planning process, we will reach out for your thoughts and feedback.

I want to thank NEFA's chief operating officer Jug Chokshi, who served as NEFA's interim executive director, and the full staff for their passion for our work and for supporting each other. Their conviction is reflected in the ways in which we support artists and organizations to do what they do best. I also want to thank our partners at the National Endowment for the Arts, the U.S. Regional Arts Organizations, the six New England state arts agencies, as well as our donors, grantees, and collaborators, whose support makes NEFA's work possible.

In fiscal year 2023, NEFA:

- Awarded 457 grants totaling over \$4.3 million to artists and cultural organizations in New England and across the nation.
- Hosted the 20th annual Idea Swap, where New England-based nonprofit cultural organizations and touring artists gather to network and share ideas for touring projects. This was the first in-person Idea Swap since the pandemic.
- Completed a leadership transition with the help of a board search committee and an enthusiastic staff.

I hope you'll learn a bit more about our programs as you peruse this report. As always, we value your feedback and support.

SUPPORT

ADVANCING EQUITY

Feedback from grantees and the field at large is essential to NEFA's program design. The Public Art program staff made changes across their grants, resulting in increased flexibility, new learning cohorts, and in the case of the Public Art for Spatial Justice (PASJ) grant, an increase in the grant amount and the length of the grant period, enabling artists to work with increased care and intentionality. Launched in 2020, PASJ was created in response to the perpetuation of systemic racism across the nation with the aim to support public art making that helps us see, feel, experience, and imagine spatial justice now.

"We aren't looking for artists to do twice as much with the increase in funding and time, but rather to be able to move with more care and intentionality in the artmaking process."

CONNECTBUILDING NETWORKS

CreativeGround, NEFA's website for creative economy network and knowledge building since 2014, was completely overhauled with essential technical upgrades and a focus on accessibility, data sharing, and community engagement. The platform enables the creative people and places at work in the six New England states to share who they are, what they do, and what they contribute, and serves as the official cultural directory for the region's state arts agencies. Built on NEFA's 45+ year history of defining the people and places of the creative sector and analyzing the economic impact of where they work and with whom, CreativeGround remains the only searchable creative economy research database/asset map in the U.S. that is updated directly by the community.

STRENGTHENINVESTING IN CULTURE

The National Theater Project offers a full system of support for devised theater, which, in addition to funding, animates an informed, interactive network of producing theaters, presenters, and ensembles. Since 2010, NTP has infused over \$11 million into the field. An evaluation of the first 10 years of the program demonstrates:

- How NEFA's equity, diversity, intersectionality, and accessibility (EDIA) values drive the program design.
- How diversifying and strengthening the field are reflected in the grantees and project tours.
- How NTP's regional convenings and cohort meetings remain an essential piece of program design.

 How the program design strengthens connections among participants and the field at large.


SUPPORTING ARTISTS & COMMUNITIES IN NEW ENGLAND AND BEYOND


Today, NEFA's programs are regional, national, and international in scope, supporting artists and communities through grants and other resources including workshops, convenings, research, and online tools.
